**Re: Appeal 1701-0145AC (Anne Rensonnet v. Jan Uttl)**  
**Letter from Registrar, dated May 30, 2017, advising that the Appeal has been scheduled for October 10, 2017, instead for June 12, 2017**

Dear Sir/Madam:

The Registrar just informed me that this fast track appeal will not be heard on June 12, 2017, as the Alberta Rules of Court (the Rules) require but that it will be heard four months later on October 10, 2017, as Ms. Rensonnet (the Mother) demanded. This is inappropriate, contrary to the plain language of the Rules, and brings the administration of justice in Alberta in disrepute.

On May 3, 2017, Justice Marriott “heard” Ms. Rensonnet’s Application and my Cross Application. During that hearing, Justice Marriott made up her mind before hearing any evidence, did not examine the evidence, refused to hear the arguments, and continued on with the hearing even though she became aware that she was familiar with the parties (in fact, Justice Marriott was my former lawyer who I fired for her inability to proceed swiftly to set aside Ms. Rensonnet’s inappropriate ex parte that started this litigation in 2013).

I appealed the judgment of Justice Marriott. Following the Rules, on May 19, 2017, I filed the factum and all necessary documents. The Rules **14.34(1), 14.34(2)(a)** are clear that the Registrar **must** schedule fast track appeals on the Civil Appeal Hearing List if the factum and other documents are filed 20 or more days before the opening of the sittings. Thus, the Registrar was required to place this appeal on the Civil Appeal Hearing List for June 12, 2017. At the time I filed the factum and other documents, the June 12, 2017 date was available.

Instead of following the Rules and placing the appeal on the list for June 12, 2017, the Registrar sent some letters to Ms. Rensonnet and I (which I have yet to receive) suggesting that the dates available for the appeal is June 12, 2017, and several dates in October 2017. I learned about these letters from Ms. Rensonnet’s letter to the Registrar where Ms. Rensonnet disagreed with the Appeal to be heard on June 12, 2017, because she incorrectly claimed that her factum was due only after June 12, 2017.

On May 26, 2017, immediately after receiving Ms. Rensonnet’s letter, I faxed the Registrar quoting the Rules and asking that they be followed and appeal be heard on June 12, 2017, as required by the Rules. I also asked for the copies of the letters sent to Ms. Rensonnet that I have not yet received.

I request that this appeal be heard on June 12, 2017, as required by the Rules for fast track appeals. In fact, I downloaded the Hearing Lists on May 30, 2017 at 22:10, and they show that there are number of slots available.

I also request that you investigate why the Registrar yielded to Ms. Rensonnet’s demands to schedule the appeal to October 10, 2017. It is inconceivable that the Registrar would not know the Rules as to when the matters must be scheduled and relied on Ms. Rensonnet’s false submission to the Registrar

instead.

It appears that this is a systemic problem. About an year ago, an appeal was scheduled for June 1, 2016, and Ms. Rensonnet made every effort to delay it into fall of 2016. The Registrar initially took her position and even claimed that the Court of Appeal has no jurisdiction until formal order from the lower court is filed. It took several letters to have the appeal heard in accordance with the rules.

The Appeal Record, Appellant's Factum and Extracts of Key Evidence have been all filed on May 19, 2017, which is 24 days before opening of the sittings on June 12, 2017, and therefore the Registrar is correct in following the rule 14.34(2) and scheduling the appeal to be heard on June 12, 2017.

I do not consent to any adjournment to October, which is additional 4 months later. I have every confidence that the Rules of the Court will be followed. Ms. Rensonnet is plainly incorrect in believing that her factum is due *after* June 12. The relevant rules are quoted below for Ms. Rensonnet's benefit.

**14.34(1)** The Registrar must schedule fast track appeals in accordance with these rules.

(2) The Registrar must place on the Civil Appeal Hearing List

(a) any fast track appeal for which the Appeal Record and the appellant's factum and Extracts of Key Evidence have been filed 20 or more days before the opening of the sittings, and

(b) any fast track appeal that a case management officer directs to be scheduled for hearing.

(3) Despite subrule (2), the parties may, no less than 20 days before the opening of the sittings, consent to an adjournment of the oral hearing of a fast track appeal to no later than the next sitting of the Court, provided that the appeal has not previously been adjourned more than once.

**14.24(1)**

(b) the respondent's factum or letter of intention not to file a factum must be filed and served before the earlier of

(i) one month after service of the appellant's factum,  
and

(ii) 10 days before opening day of the sittings at which the appeal is scheduled to be heard.
